

I. TAKE NOTICE

- (1) Where an applicant under s. 39, 48, or 49 whose application for admission is approved is not admitted as a member of the Society within one (1) year of the date of such approval, the application lapses and any fees paid by the applicant are forfeited to the Society (*Rule 50(1)*).
- (2) Where an applicant whose admission is approved as a student-at-law under section 40 does not commence his or her articles within one year after the date of such approval, the application lapses and any fees paid by the applicant are forfeited to the Society (*Rule 50(2)*).
- (3) Where an application for admission under section 39, 40, 48 or 49 is not approved or withdrawn, the Secretary shall refund all fees and levies paid by the applicant except the application fee, which is forfeited to the Society (*Rule 50(3)*).
- (4) Under *Rule 102(1)*: A provision of these rules requiring the payment of any fee or levy is deemed to also require the payment of any federal or Territorial taxes payment in respect of the levy or fee.
- (5) Under *Rule 102(3)*: Unless these *Rules* otherwise provide, payment of all fees, levies, fines, penalties, insurance premium assessments, insurance deductibles, custodianship costs and any other amount assessed, levied, or imposed at any time under the *Act* or these *Rules* is a condition of the practice of law in the Nunavut Territories and must be paid to the Society prior to the issuance of the Society of an annual certificate of membership, a certificate of admission as a student-at-law or a restricted appearance certificate.
- (6) Under *Rule 103*: The fees set out in Schedule A are:
 - a. payable in advance to the Society; and
 - b. exclusive of the assurance fund levy and any federal or Territorial taxes payable in respect of those fees.
